SILT, newly-launched in January, already owns its first farm in Honey Creek IA with a second being donated by a woman landowner in Corydon later this year. More than 30 landowners, mostly elderly women or couples from around lowa, have contacted SILT to discuss donating their land to the group which promises to permanently protect it while placing next gen farmers on the ground to grow fruits, vegetables and small livestock in nature-friendly ways. SILT standards require farmers on SILT land to transition to certified organic, certified naturally grown, food alliance certified and/or animal welfare approved production.

FarmHer Brings Women in Agriculture into Focus submitted by Tama County WLL

The evaluations said it all. When asked what she valued most about the experience, one participant responded, "I really felt connected, like she's showing photos of us, of me."

A crowd of thirty people was captivated by Marji Guyler-Alaniz at Tama County WLL's September 2nd learning session, sharing photos of female farmers and what is now her passion-- FarmHer. Setting out to change the perception of women in agriculture, Marji has created FarmHer images with 90 women so far, sharing their agricultural stories through her photography.

While sharing these images, Marji noted many of her photos don't show the face of her subject, concentrating rather on what the woman is doing. Large group conversation surrounding this focused on how the subject's hands could be those of any of us who were in the room, doing tasks that many of us do every day.

This prompted another participant to share that she learned "a new way of being involved in the agriculture world and promote it in a new light." Several evaluations requested future learning sessions on how to share our own agricultural stories with our communities' non-farming sectors.

Attendees were also fascinated in and inspired by Marji's own story of her lifelong love of photography, which came in handy after "jumping off the cliff" and quitting a high-paying job in 2013 without a plan.

"Everyone thought I was completely insane," she said.

And we're so glad of it!
